1. Voluntary Participation

I acknowledge that I am voluntarily participating in this event at Greek Peak Mountain Resort. If signing for a minor, I have agreed to allow my child to voluntarily participate in this event.

2. Assumption of Risk

RECKLESS SKIING: Skiing out of control can cause hazard to oneself and other skiers or otherwise violate Article 18 (a misdemeanor). Offenders may be required to leave the area and may be denied skiing privileges for a period of time as deemed appropriate by Greek Peak Mountain Resort Management. Skiers must follow posted and oral directions and avoid acts of carelessness that could cause injury. I agree that all disputes under this contract and/or lawsuits arising from use of the facilities at Greek Peak Mountain Resort Ski Area shall be litigated exclusively in the Supreme Court of the State of New York, County of Cortland, or in the United States District Court for the 6th Judicial District of New York. **ALL PERSONS USING GREEK PEAK MOUNTAIN RESORT FACILITIES ARE BOUND BY THE REQUIREMENTS OF THE FOREMENTIONED CODE. BY LAW YOU ARE REQUIRED TO READ, UNDERSTAND, AND ACCEPT "SKIER RESPONSIBILITIES AND DUTIES" AND "WARNING TO SKIERS" POSTED AT TICKET WINDOWS AND THROUGHOUT THE RESORT. WARNING TO SKIERS.** Downhill skiing, like many other sports, contains inherent risks including but not limited to the risk of personal injury, including catastrophic injury or death or property damage, which may be caused by variations in terrain or weather conditions or surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps, or other persons using the facilities, or rocks, forest growth, debris, branches, trees, roots, stumps, or other natural objects or manmade objects that are incidental to the provisions or maintenance of a ski facility in New York State. New York law imposes a duty to you to become apprised of, and understand, the risks inherent to the sport of skiing, which are set forth above, so that you may make an informed decision of whether to participate in skiing notwithstanding the risks. New York law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent in skiing. If you are not willing to assume all of these risks and abide by all of these duties, you must not participate in skiing at this ski area. Instruction and education (Article 18) for a skier relative to the risks inherent to the sport, and the duties for skiers is available upon request at the resort at all times. **ALL PERSONS USING THE GREEK PEAK MOUNTAIN RESORT FACILITIES ARE BOUND BY THE REQUIREMENTS OF THE AFOREMENTIONED CODE. A COMPLETE COPY OF ARTICLE 18 IS AVAILABLE AT THE LIFT TICKET WINDOW. IF YOU WOULD LIKE A COMPLETE COPY OF ARTICLE 18 PLEASE CONTACT THE RESORT AND WE WILL MAIL ONE TO YOU.**

3. Effect on Legal Rights

I have read this agreement carefully and understand its contents. I have read this agreement to my child and he/she has acknowledged that he/she understands its contents. I am aware that the agreement includes an expressed assumption of risk. I understand that this agreement may affect legal claims for damages in the event of death or any injury to me or my child. I acknowledge that any questions I or my child have about this agreement or the risks inherent in participating in the program and competitions have been answered to my and my child's satisfaction. I signed this document of my own free will.

4. Controlling Law

I agree that the terms of this agreement are binding on me and my child, and shall be governed by the Laws of the State of New York.

COVID-19 Employee-Screening Procedures

All employees reporting to work will be screened for respiratory symptoms, and other Covid related symptoms and have their body temperature taken as a precautionary measure to reduce the spread of COVID-19.

Every employee will be screened, including having his or her temperature taken, when reporting to work. Employees should report to the Symptom Checking Stations inside their work areas, upon arrival at work and prior to entering any other areas of **Greek Peak Mountain Resort** property.

Each employee will be screened privately by a designated person or may utilize a self-monitoring station, using a touchless forehead/ temporal artery thermometer. The employee's temperature and answers to Covid related symptom questions will be documented, and the record will be maintained as a private medical record with Human Resources.

An employee who has a fever above 100.4 degrees Fahrenheit or who is experiencing coughing, shortness of breath or other symptoms will be sent home. The employee should monitor his or her symptoms and call a doctor or use telemedicine if concerned about the symptoms.

An employee sent home can return to work when:

- He or she has had no fever for at least three (3) days without taking medication to reduce fever during that time; AND
- Any respiratory symptoms (cough and shortness of breath) or other symptoms have improved for at least three (3) days; AND
- At least ten (10) days have passed since the symptoms began.

****An employee may return to work earlier if a doctor confirms the cause of an employee's fever or other symptoms is not COVID-19 and releases the employee to return to work in writing****

An employee who experiences fever and/or respiratory or other Covid related symptoms while home should not report to work. Instead, the employee should contact his or her immediate supervisor for further direction at least 2 hours prior to the start of scheduled shift.

Greek Peak & Hope Lake Lodge have policies in place to protect the employees, the customers and the company alike. Policies does not ensure the overall safety and well-being of each employee.

COVID-19 Assumption of Risk and Waiver of Liability Relating to Coronavirus:

COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. **Greek Peak Mountain Resort** has put in place preventative measures to reduce the spread of the virus; however, the company cannot guarantee that you will not become exposed or infected with COVID-19 while at work. By signing this agreement, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you may be exposed to or infected by the virus during your course of employment. Exposure or infection may result in personal injury, illness, permanent disability, and possibly even death. You are voluntarily agreeing to assume all of the foregoing risks and accept individual responsibility for any exposure. You would hereby release, discharge, and hold harmless the company, its employees, and representatives, of and from any claims, including all liabilities, damages, costs or expenses of any kind arising out of or relating to your potential exposure. Your signature indicates you understand and agree that the company will do what it can to prevent your exposure at work, whether a COVID-19 infection occurs before, during, or after your working hours.
